## **CHARGING AND REMISSIONS**

The governing body cannot charge parents and pupils for any activity unless it has drawn up a charging policy. Moreover, when made, charges per pupil cannot exceed the actual cost incurred, which means that pupils who can pay should not be charged extra to cover the costs of those who cannot afford to.

The governing body must not charge for any activities which take place when the school is actually in session, excluding the break in the middle of the day. The exception is musical instrument tuition for individual pupils or pupils in groups, as long as such teaching is not an essential part of the National Curriculum or a public examination syllabus being followed by the pupils(s).

If the school wishes to run an activity during the school day for which it would need contributions from parents or others, it can invite voluntary contributions. However, no child should be excluded from such an activity because his or her parents cannot or will not contribute.

The school can charge for optional, extra activities provided mainly or wholly outside school hours as long as such teaching is not an essential part of the National Curriculum or religious education. Activities which are an essential part of the syllabus for an approved examination must be provided free.

Chapter 10 of *A Guide to the Law for School Governors* provides further, detailed guidance on residential stays, use of mini-buses, public examinations and activities provided during school hours by external bodies.

### **Status**

### **Purpose**

The purpose of the policy is to ensure that, during the day, all children have full and free access to a broad and balanced curriculum.

The school day is defined as:

8.55am – 3.15pm (Reception to Year 6)

9.00am -3.15pm Mon & Tues and 9.00am – 11.30am Wed (Nursery)

### **What was consulted?**

The policy has been informed by *A Guide to the Law for School Governors*.

### **Relationship to other school policies**

The policy complements the school's equal opportunities policy, curriculum policy and teaching and learning policy.

## **Roles and responsibilities of Head Teacher, other staff and Governors**

The HeadTeacher will ensure that the following applies:

### *During the school day*

All activities that are a necessary part of the National Curriculum plus religious education will be provided free of charge. This includes any materials, equipment and transport to take pupils between the school and the activity. It excludes charges made for teaching an individual pupil or groups of up to four pupils to play a musical instrument. Unless the teaching is an essential part of either the National Curriculum or a public examination syllabus being followed by the pupil(s), we will make a charge.

Voluntary contributions may be sought for activities during the school day which entail additional costs (e.g. sponsored events / charity donations).

In these circumstances no pupil will be prevented from participating because his/her parents cannot or will not make a contribution.

From time to time we may invite a non school based organisation such as theatre groups/ authors etc to arrange an activity during the school day. Such organisations may wish to charge parents, who may, if they wish, ask the headteacher to agree to their child being absent for that period.

### *Optional activities outside of the school day*

We will charge for optional, extra activities provided outside of the school day, for example clubs and music tuition. Such activities are not part of the National Curriculum or religious education, nor are they part of an examination syllabus.

### *Education partly during the school day*

If a non-residential activity happens partly inside the school day and partly outside of it, there will be no charge if most of the time to be spent on the activity falls within the school day. Conversely, if the bigger proportion of time spent falls outside of the normal school day, charges will be made. When such activities are arranged parents will be told how the charges were calculated.

### *Residential Stays*

Charges will be made for board and lodging, except for those pupils who are in receipt of Income Support, Family Credit, Disability Working Allowance or an income based Jobseekers Allowance.

Other charges will be made to cover costs when the number of school sessions missed by the pupils totals half or more of the number of half-days taken up by the activity. In such cases parents will be told how the charges were calculated.

### ***Calculating Charges***

When charges are made for any activity, whether during or outside of the school day, they will be based on the actual costs incurred, divided by the total number of pupils participating. There will be no levy on those who can pay to support those who can't. Support for cases of hardship will come through voluntary contributions and fundraising.

Parents who would qualify for support are those who receive benefits e.g. those in receipt of Income Support, Family Credit, Disability working allowance or an income-based Jobseeker's allowance.

The principles of best value will be applied when planning activities that incur costs to the school and / or charges to parents.

### **Arrangements for monitoring and evaluation**

The Finance Committee of the governing body will monitor the impact of this policy by receiving a financial report on those activities that resulted in charges being levied, the subsidies awarded (without giving names) and the source of those subsidies, each term.
